The Missouri Department of Transportation will hold a public hearing on **Thursday, November 30, 2017**, to discuss improvements to the Missouri Route 87 bridge on Interstate 70 in Boonville.


The public hearing will be held from 4 p.m. until 6 p.m. at the Open Bible Praise Center, 16991 Highway 87 in Boonville. The facility is accessible to people with disabilities.

Representatives from MoDOT will discuss removing and replacing the Route 87 overpass bridge, proposed construction phasing and traffic flow plans. The purchase of right of way will be necessary to complete the project.

The public hearing is an open house format. The public is invited to attend the hearing at any time between 4 p.m. and 6 p.m. to ask questions of MoDOT staff and provide comments.
